Financial Update

Overview (as of June 15)

- The ISACA Los Angeles Chapter uses the cash accounting method, has no liabilities, and is financially sound.
- The fiscal year of the Chapter runs from July 1 to June 30
- The chapter has sufficient reserves to provide continuous operations and benefits to the chapter members in unexpected events or economic downturns.
- We are required to submit our financial statement to ISACA International on an annual basis after the AGM meeting.
- Our financial statement is to be audited/verified by our independent audit chair, Alexandra Molieri, on an annual basis. Our audit chair prepares an audit/verification letter to the board and ISACA International. The audit will begin after the close of our fiscal year (June 30).
